

2022 La Porte County Draft Horse Show Fancy Hitch Entry Form *For entries not showing in the Six Horse

Individual entries are welcome, but stalls may not be available. Classes open for entry include: cart classes, team, unicorn, and 4 horse. Payouts will be based on placings.

General rules/info:

- Upon arrival at the show you must check in at the office next to the draft horse arena for stall assignments and completion of paperwork.
- All show entries must have submitted this entry form to the show organizer.
- Check-in time for hitch teams will begin at 3pm CST Wednesday, September 7.
- Exhibitors must have proof of health papers and negative test for Equine Infectious Anemia/EIS (COGGINS) conducted within one year of the date of the show.
- All adult class drivers must be at least 18 years of age and out of 4H.
- All drivers under 18 years of age must have an experienced adult driver to accompany them in the ring.
- Only drivers and lineman are permitted on wagons in all events—absolutely no riders.
- Gate steward has final rule on safety as to who may enter the show arena.
- Loading of horses is only permitted after the completion of the last class.
- Schedule can be revised at the discretion of the show organizers.
- There are no refunds. The Judge's decision is final.
- Camping sites are available at the La Porte County Fairgrounds; forms are available.
- \$105 per horse entry fee includes one box stall with sawdust bedding; \$60 per horse entry fee includes one tie stall with sawdust bedding. Additional box stalls are \$105 each.
- Stalls are assigned by the show organizers; barns will be at capacity.
- The hitch horse entry fee of \$105 per horse will also include that horse's entry fee to the halter events. A separate entry form for halter events must be submitted to include horse registration information.
- Rain date is Sunday, September 11.
